COMMISSION REPORT:

The commission heard Keith Kocher, director of gaming facilities for the Kansas Lottery, report on the current status of casinos:

- Construction on the Hollywood Casino in Kansas City, Kansas continues.
- The financial results from the Boot Hill Casino and Resort are good.
- On Wednesday, September 8, the three applicants in the Southwest Zone were scheduled to give their presentations to the Lottery Board. Harrah's withdrew their application prior to the presentation. Two applicants remain – Global Gaming, which is proposing a facility near Wellington; and Peninsula, which is proposing a facility at the Mulvane turnpike exit.

Clint Patty, outside legal counsel for Butler National Service Corporation, d.b.a. Boot Hill Casino and Resort, introduced Mark Kashuda, general manager at the casino, who gave Boot Hill's report:

- Mr. Kashuda outlined his background in the casino industry.
- He emphasized the difficulty of predicting revenues in a new market. It is obvious that the agricultural business has an effect on the market. His experience has been that there is

always a dip in business during the month of June. The main difference in revenue between July and August was in table games.

- Construction on the hotel and convention center is anticipated to begin in November with completion scheduled for 4th quarter 2011.

Jeff Boerger, president of Kansas Speedway Development Corporation, reported on the Hollywood Casino at the Kansas Speedway.

- Construction progress is good and, in spite of some recent rain delays, they are still on schedule to meet their deadline for the first half of 2012. Road and utility construction is currently in progress.
- He distributed the monthly construction report from Turner Construction.

The revised budget is a reduction of approximately \$4.3 million from the approved 2011 budget. Jamie Nickoley of the State Gaming Agency reported briefly on the tribal gaming budget.

- He presented and discussed a quarterly report outlining the casino licensing status.

The commission heard a staff report from Mr. Deines:

- Eleven people are now on the problem gambling self-exclusion list with one more currently pending.
- During the month of August, 27 people received help on the Problem Gambling Help Line.
- There were 401 visitors to the Problem Gambling website –

nearly 100 more than in previous months.

- Training and informational sessions will soon be starting in the Kansas City, KS, and Wichita areas similar to the ones held in Dodge City prior to the opening of the casino there.
- SRS has formed a Problem Gambling and Addictions Fund Advisory Committee. Mr. Deines will be representing the Problem Gambling Alliance and the KRGC on the committee.
- It is expected that the new KRGC website will be available within the next 10 days to two weeks.

STAFF AGENDA MEMORANDUM

DATE OF MEETING: October 13, 2010

AGENDA ITEM: Continued discussion on parimutuel funds with remaining balances

PRESENTER: Patrick D. Martin, Interim Executive Director

COMMISSION ACTION REQUIRED/REQUESTED: Commission discussion, no formal action needed.

The legislature created nine different funds for various parimutuel activities. With no parimutuel racing in Kansas and no current prospects for parimutuel racing, the commission requested discussion of what to do with those parimutuel funds that have a balance.

For ease of discussion, staff has divided the remaining funds into two different categories: (1) those that are ripe for consolidation into the State Racing Fund; and (2) those that impact breed development and have relatively higher balances.

Category 1: Three funds that could be consolidated into the State Racing Fund.

In our FY2011 budget, staff proposed moving the balance of three dormant and relatively small funds to the State Racing Fund, K.S.A. 74-8826. That fund has a current balance of \$68,866 and may broadly be used for "all operating expenses of the commission and [for promoting] horse and greyhound racing." *Id.* The three dormant funds are the:

1. *Racing Reimbursable Expense Fund*, K.S.A. 74-8827, has a current balance of \$11,472. The current spending restriction on that fund is for "expenses incurred by the commission for the processing of fingerprints . . . and for payment of the services of assistant animal health officers, stewards and racing judges at racetrack facilities. . ." Because of racetracks are closed, there are no expenses requiring payment from that fund.
2. *Racing Investigative Expense Fund*, K.S.A. 74-8835, has a current balance \$19,774. The current spending restriction on that fund is for "expenses of investigation of an applicant's qualifications for an organization license, facility owner license or facility manager license . . ." Because of racetracks are closed, there are no expenses requiring payment from that fund.
3. *Horse Fair Racing Benefit Fund*, K.S.A. 74-8838, has a current balance \$1.00. The current spending restrictions on that fund all essentially require that the fund shall be expended for the benefit of fair meets. Because there is only \$1.00 in the fund, distribution is impracticable.

Consolidating those three funds in the State Racing Fund would result in a balance of \$100,112 and would allow the agency to have either have seed money in the event parimutuel racing resumed in Kansas or to promote horse and greyhound racing.

Category 2: Breed Development Funds.

Three other parimutuel funds have balances and are related to breed development:

1. *Horse Breed Development Fund*, K.S.A. 74-8829, has a current balance of \$51,913. The current spending restrictions on that fund require allocation “corresponding with the various breeds of horses which are participating in live races with parimutuel wagering conducted by organization licensees in direct proportion to the number of horses in each category participating in such live races . . .” and then shall be used for purse supplements; stakes and awards; stallion awards; breeder awards; and equine research. *Id.* (emphasis added).

There are currently no “live races with parimutuel wagering conducted by organization licensees.” Unlike the greyhound fund, below, this statute does not provide direction on how to apportion the money in this fund if there is no live racing.

2. *Greyhound breeding Development Fund*, K.S.A. 74-8831, has a current balance of \$87,012. The statute creating that fund gives two directions on how to spend it. First, as a general rule, “Moneys credited to the [GBDF] shall be used only for the benefit of greyhounds.” *Id.* at (c). Second, there are specific directions that the funds should be spent in this way:
 - a. 15% shall go to greyhound tourism fund (via approval by the secretary of commerce); *Id.* at (b)(1)
 - b. 35% shall “be used for research conducted within the state of Kansas relating to the prevention of injury to and disease of greyhounds;” *Id.* at (b)(2)
 - c. 50% shall be divided equally among Kansas-whelped greyhounds in a racetrack’s kennel immediately before the racetrack’s closure. Those greyhounds are to be identified in a roster compiled by the commission, subject to certain conditions. *Id.* at (e).
3. *Greyhound Promotion & Development Fund*, K.S.A. 74-8842, has a current balance of \$39,681. The current spending restrictions on that fund are that “Moneys deposited into the fund shall be distributed to the organization contracted with by the [KRGC] to administer the official greyhound registry in Kansas.” *Id.*

There is no current contract with such an organization.
